IMPORTANT- READ CAREFULLY

THIS BUILDING WILL BE FUMIGATED WITH LETHAL GASES ON THE DATE(S) INDICATED ABOVE. ALL PERSONS AND ANIMALS MUST VACATE THE PREMISES ON OR BEFORE ARRIVAL OF THE FUMIGATION CREW.

UNDER NO CIRCUMSTANCES CAN ANYONE ENTER THE BUILDING UNTIL THE FUMIGATION COMPANY'S NOTICE IS POSTED GIVING THE TIME AND DATE FOR SAFE RE-ENTRY.

“State law requires that you be given the following information: CAUTION-PESTICIDES ARE TOXIC CHEMICALS. Structural pest control companies are registered and regulated by the Structural Pest Control Board, and apply pesticides which are registered and approved for use by the California Department of Pesticide Regulation and the United States Environmental Protection Agency. Registration is granted when the State finds that based on existing scientific evidence there are no appreciable risks if proper use conditions are followed or that the risks are our outweighed by the benefits. The degree of risk depends upon the degree of exposure, so exposure should be minimized”

If within 24 hours you experience symptoms of dizziness, headache, nausea, reduced awareness, slowed movement, garbled speech, or difficulty in breathing, leave the structure immediately and seek medical attention by contacting a physician or Poison Control Center (800) 876-4766 and notify your pest control company. The warning agent, chloropicrin, can cause symptoms of tearing, respiratory distress and vomiting. Entry into the space during fumigation can be fatal.

IT IS THE RESPONSIBILITY OF THE OWNER, OCCUPANT, OR OWNER'S AGENT TO HAVE ALL ITEMS ON THIS CHECKLIST COMPLETED BEFORE THE CREW ARRIVES; FAILURE TO DO SO MAY POSTPONE THE FUMIGATION.

1. Remove all people from the property(s) to be fumigated. Remove all pets (including fish and birds). Animals must be removed from the yard (cats included); the water in the fish tank does not have to be drained. Unplug all filters.
2. Remove all Foods, feed and medicines not factory sealed in glass or metal containers with an air tight seal. This includes anything that might be orally ingested, such as candy and gum. It also includes foods in freezers and refrigerators. When and if available NYLOFUME BAGS (not trash bags) may be used in lieu of removal. **ANY FOOD OR MEDICINES NO FACTORY SEALED IN GLASS OR METAL CONTAINERS WILL BE THROWN OUT! YOU WILL NOT BE REIMBURSED FOR ANY LOSS.**
3. Remove baby mattresses enveloped with plastic. Water beds excluded. Remove plastic covers from mattresses. If Methyl Bromide is used, remove wet suits and all SCUBA equipment. If Vikane is used all vehicles, boats, trailers, campers, etc... left in garages/carports during the fumigation must be unlocked (including trucks for aeration purposes). If using Methyl Bromide they must be removed.
4. **Prior to the fumigation the building owner must: Cut all trees, bushes, ivy and other plants back a minimum of one foot (12 inches) from the perimeter of the building. Pull back all decorative bark and gravel a minimum of one foot from the building perimeter. Remove all plants from under patio covers and attached decks. Wet down a path in the soil along the building foundation. The added moisture allows for an improved ground seal and helps protect any plant root systems nearby. Remove all antennas mounted to the structure. If we remove them, we will assume NO responsibility for any damage or alignment.**
5. The occupant must turn off any air conditioning unit(s). All burglar or movement alarms, exterior lights on timers and automatic sprinkler systems must be turned off. Also, make sure computers are turned off and cooled prior to fumigation. **ELECTRICITY AND WATER MUST BE TURNED ON DURING THE FUMIGATION.**
6. We must have access to all areas within the structure, including rooms or garage(s) kept locked. If walk-in or large safes exist, you **MUST** be present to open safe for our inspection before re-locking the safe. **THIS IS REQUIRED BY LAW.** For insurance purposes, we request you take with you any valuables you deem necessary, such as jewelry, furs, etc...
7. Utility gas will be turned off, in cases where pilots will not remain lit, or where the heater, water heater, or oven are old, and special expertise is needed in lighting, we will request that you contact the gas company to relight the pilot.
8. **IN CASE OF RAIN OR STRONG WINDS OR PROPERTY NOT BEING PROPERLY PREPARED FOR THE FUMIGATION, THE JOB WILL BE POSTPONED. IF THE JOB IS POSTPONED AND RE-SCHEDULED FOR ANOTHER DAY, OR IF ANY REASON A PROPERTY IS TO BE RE-FUMIGATED AGAIN, FARMER TERMITE CONTROL SAN DIEGO NOR THE FUMIGATION LICENSEE IS RESPONSIBLE FOR FOOD AND LODGING FOR ALL OCCUPANTS AND/OR PETS EITHER DAY. PLEASE LEAVE AN EMERGENCY PHONE NO. WHERE WE CAN REACH YOU SHOULD THIS OCCUR.** We do not wish to inconvenience you by having you wait for our arrival the day of the fumigation, when you decide on a date, make arrangements with regard to KEYS AND OCCUPANTS NOTICE. If you choose to wait for our arrival, a TIME FRAME will be available after 7:00 AM on the day of your fumigation.
9. The roof surface and perimeter areas of the building must be walked upon. Where old brittle wood shingles, old shake, old composition, new or old tile, aluminum or specialty roofs are present, there will be damage. Neither the Prime Contractor or Fumigation licensee will assume liability or responsibility for such damage or consequential damage that occurs to roofs or roof coverings and areas below same, gutters, electrical wiring, patio and awning coverings, solar heating panels or related plumbing, living plants, trees or landscaping at/adjacent to the subject property.
10. We do not provide on-site security during the fumigation procedure or after the tent(s) or seals are removed, and as such our insurance does not cover malicious vandalism or theft (screened windows are left open and unlocked for fumigant ventilation of the building); if the home owner or occupant wishes such security, same would be at his/her additional expense for such arrangements and is NOT the liability of Farmer Termite Control San Diego or Fumigation licensee.
11. Due to the fragile nature in which mobile homes are constructed, some damage may occur to CARPORTS, ROOF RAILS, SIDING, and AWNINGS OR TRIM. Decorative ground cover will be disturbed and plastic beneath ground covering may be torn in order to get a proper ground seal. We can assume no liability or responsibility for replacement or repair of same.
12. Where climbing plants, fences, trellises or vines must be detached from the building(s) or any plants, trees, vines, grass etc... that must be covered during the fumigation dies or there is damage, we assume no liability or responsibility for replacement or repair of same.
13. Fumigation where masking tape is used ("tape" fumigation in lieu of "tarp" fumigation) and where the painted surface is old or oxidized may result in some peeling of paint. Some painted surfaces will chip or peel if the undercoating was not properly applied, even though these surfaces appear to be in good condition. (The tape we use will not peel paint that is properly applied), therefore we assume no responsibility for any such damage. Spray glue used to help tape adhere to surface may also leave marks; we assume no responsibility for any such damage.
14. All exterior doors (including water heater cabinet) to the building **MUST** be able to be locked, if no hasp or lockable devices exist, state law requires nailing the doors shut. If the homeowner or his/her agent has not

provided such locks, and nailing is then performed by the fumigation licensee, we will not assume any liability for damage to the door jamb. Nailing or locking is required to keep out any person such as a small child from being accidentally trapped inside.

15. If tarping the building will require entrance to your neighbor's yard by the fumigators, the neighbor's pets must be removed or tied up in the yard to allow our crew access; it will be up to YOU to inform your neighbor(s) of the impending fumigation and date of same and you're lacking to do so will not be our liability. Also, your neighbor's plants may be affected if growing on/or directly adjacent to your building; please acquire your neighbor's signature and have him/her sign here. I/we the undersigned have read, reviewed, and agree to all the provisions contained herein and to items listed on the reverse side hereof that would be pertinent to me/us:

I/we further stipulate that if the building(s) have tenant occupants that I/we or our authorized agent or manager has/will disperse copies of this Notice to all such occupants by the use of U.S. mail, posting on the front door, or hand direct delivery.

THIS OCCUPANTS NOTICE MUST BE SIGNED AND IN THE POSSESSION OF OUR CREW PRIOR TO COMMENCEMENT OF FUMIGATION. FAILURE TO DO THIS WILL POSTPONE THE FUMIGATION.
